Terms & Conditions ("Agreement")

Please read these Terms & Conditions ("Agreement") carefully before signing up or using the app "Syrian Messenger".

By signing up or using the Application, you are agreeing to be bound by the terms and conditions of this Agreement.

If you do not agree to the terms of this Agreement, do not sign up or use the Application.

About Syrian Messenger

Connect. Send. Transport. Help others and make money.

Syrian Messenger is a service that aims to connect people that are traveling countries with limited public or corporate postal services with other people who are in need to send goods, documents or money in or out of these countries.

Using Syrian Messenger

The service is trying to accomplish this aim by supplying a platform where users can either publish Offers or Requests or search for Offers or Requests by other users. User reliability can be deducted from the user profile, which may include personal information, reviews by other users, information about verification statuses and the number of successfully completed agreements. Users are able to communicate on the platform in order to get in contact, clarify questions about Offers and Requests and specify the terms of a possible contract between users. Once two users have negotiated an agreement they may use the agreement form of the App to record the content of the agreement and track the stages of the transaction.

Syrian Messenger has been created to form a safe platform to interact, yet we advise you to be careful with what kind of personal data you are sharing. Syrian Messenger will not monitor the content on its platform nor control user registration.

By accepting this agreement the user consents to comply with all laws and regulations, especially those relevant for import/export and traveling in the countries of origin and destination of the concerning trip. Before traveling we strongly advise you to get informed about restrictions on official government websites.

Users are not allowed to make any profit from their services offered on this platform, i.e. the monetary compensation always has to be lower than the cost of travel.

Disclaimer of Warranties / Limitation of Liability

Agreements made on this platform are solely between users. Syrian Messenger is not liable for any violation of these agreements. Users may inform Syrian Messenger about other users in case they have evidence of fraud. If this evidence seems conclusive or a user has received several bad reviews by other users Syrian Messenger may end the Agreement with that user by denying further access to his or her account and deleting it. Syrian Messenger is not liable for any kind of data theft that may occur.

Network Access and Devices

You are responsible for obtaining the data network access necessary to use the Services. Your mobile network's data and messaging rates and fees may apply if you access or use the Services from your device. You are responsible for acquiring and updating compatible hardware or devices necessary to access and use the Services and Applications and any updates thereto. Syrian Messenger does not guarantee that the Services, or any portion thereof, will function on any particular hardware or devices. In addition, the Services may be subject to malfunctions and delays inherent in the use of the Internet and electronic communications.

Liability of Offers and Requests

Users must only publish an Offer or Request on this platform if they have the intention to make agreements with other users concerning this publication. A publication is not binding though and may be altered or deleted by the publishing user in case no agreements concerning this publication have been made yet.

License

Syrian Messenger grants you a revocable, non-exclusive, non-transferable, limited license to download, install and use the Application solely for your personal, non-commercial purposes strictly in accordance with the terms of this Agreement.

Restrictions

You agree not to, and you will not permit others to:

a) license, sell, rent, lease, assign, distribute, transmit, host, outsource, disclose or otherwise commercially exploit the Application or make the Application available to any third party.

Modifications to Application

Syrian Messenger reserves the right to modify, suspend or discontinue, temporarily or permanently, the Application or any service to which it connects, with or without notice and without liability to you.

Term and Termination

This Agreement shall remain in effect until terminated by you or Syrian Messenger.

Syrian Messenger may, in its sole discretion, at any time and for any or no reason, suspend or terminate this Agreement with or without prior notice.

This Agreement will terminate immediately, without prior notice from Syrian Messenger, in the event that you fail to comply with any provision of this Agreement. You may also terminate this Agreement by deleting the Application and all copies thereof from your mobile device or from your desktop.

Upon termination of this Agreement, you shall cease all use of the Application and delete all copies of the Application from your mobile device or from your desktop.

Severability

If any provision of this Agreement is held to be unenforceable or invalid, such provision will be changed and interpreted to accomplish the objectives of such provision to the greatest extent possible under applicable law and the remaining provisions will continue in full force and effect.

Privacy Policy

Syrian Messenger will use the information provided by the user solely to obtain its services. Data generated by the user will not be given to any third party. The registration process only requires a valid user email address. All other information is provided by choice of the user and may merely improve the quality of service. Upon termination of the user account the personal data will not be accessible to other users anymore and will be deleted after 6 months from the database if there is no ongoing litigation concerning this user.

Amendments to this Agreement

Syrian Messenger reserves the right, at its sole discretion, to modify or replace this Agreement at any time. If a revision is material we will provide at notice prior to any new terms taking effect. What constitutes a material change will be determined at our sole discretion.
